**Acknowledgement of the Assumption of Risk,
 Waiver of Negligence, and Statement of Present Liability**

I (WE) do assume all risks and hazards incidental to such participation including transportation to and from facilities located at 45431 - 23rd Street West, known as SkatePlex, USA (the "Facility"); and I (WE) do hereby waive, release, absolve, indemnify and agree to hold harmless the Athletic Amateur Union of the United States (AAU) In-line Hockey program, the Facility's sanctioning body, SkatePlex, USA, its owners, administrators, directors, agents, officers, members, employees, volunteers, or other such participants; and/or if applicable, owners or lessors of the premises; relative to the transportation and/or any and all claims out of injury to said Participant that may occur through activities or events involving Participant, while at the Facility.

I (WE) further understand that participating in roller skating and/or roller hockey are potentially hazardous activities. Participant is medically able and does reasonably understand the physical skills necessary to take part in said activities, and agrees and warrants that at any time Participant believes conditions are unsafe they shall immediately discontinue participation in the activity, and shall notify authorized staff of any potentially unsafe behavior, conditions and/or circumstances that exist.

I (WE) assume any and all other risks associated with participating in the activities of roller skating or roller hockey at SkatePlex, USA, including but not limited to falls, contact with other participants, potential for injuries, the effects of weather, (including high heat and/or humidity) and conditions of the rink. Knowing these facts, I (WE) hereby as Participant, or on behalf of Participant, the heirs, executors, administrators or anyone else who might file claim on Participant's behalf, agree and covenant not to sue. Participant, and if applicable Participant's Parents or Legal Guardian, have agreed to indemnify, waive, release, hold harmless and discharge any person(s) associated with AAU In-Line Hockey, SkatePlex, USA, including its owners, administrators, directors, agents, officers, members, employees, volunteers, and the owners or lessors of the premises, from any and all claims of liability for personal injury, death and property damage of any kind while participating in any level of roller skating or roller hockey at the Facility. Exceptions to above would be resulting negligence in which hazardous conditions are clearly and openly ignored. This release and waiver extends to all kinds of claims, whatsoever, foreseen, known or unknown.

I (WE) further grant permission to SkatePlex, USA and its owners, authorization by them to use photographs, videotapes, motion pictures, recordings, or any other temporary or permanent recording made at the Facility for beneficial purposes.

I (WE) HAVE READ THIS AGREEMENT AND FULLY UNDERSTAND THE TERMS AND CONTENTS HEREIN, AND HAVE SIGNED IT FREELY AS AN UNCONDITIONAL RELEASE OF LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW. SHOULD ANY PORTION OF THIS AGREEMENT BE DEEMED INVALID, THE BALANCE NOTWITHSTANDING SHALL CONTINUE TO BE IN FULL FORCE AND EFFECT.
